The **object of the study** is import substitution policy.

The **subject of the study** is import substitution policy in China and the Republic of Belarus.

The **purpose of the study** is to explore and characterize the structural elements of the import substitution policy in China and foreign countries at the national and supranational levels, and develop directions for its improvement.

Research methods: comparative analysis, grouping method, estimation of specific gravity, graphic.
