

include locking and sealing devices, stamps, sealer, seals, excise stamps, fluorescent markers.

Using of technical means of customs control facilitates the work of customs officers during customs control and inspection of vehicles, cargo, hand luggage, and protects the health of employees from harmful and radioactive sources.

High efficiency of control is achieved by complex application of technical means at each section of customs control, whether it is hand luggage and baggage of passengers and transport crews, control of medium and large cargo shipments and separate baggage, control of international mail, or all types of vehicles of international communication. Moreover, for customs control of each type of objects moved across the customs border certain specific types of technical means of customs control must be applied. A good knowledge of the operational and technical capabilities of the customs control system, modern methods and methods of their application and practical skills to work with them to a large extent ensures a high professional level of customs control.

Good knowledge of technical means of customs control, modern methods and their application, mastering practical skills of work with them – all this largely ensures the high professional level of customs control, starting with reasonable charges and fees to the detection of contraband.

GOODS PROHIBITED FOR IMPORT AND EXPORT IN DIFFER-ENT COUNTRIES

Запрещенные товары к импорту и экспорту в разных странах

We often scold our customs officers and officials, establishing completely ridiculous rules for the transport of certain goods, and for good reason. Every year, thousands of dissatisfied tourists remain at the border without their purchases, after they were checked by customs. Either Finnish smoked fish was suddenly outlawed, then five cans of canned food suddenly turned into a commercial batch. But in some countries they went even further - now, for transporting completely ordinary and innocuous things, you can now not only run into a fine, but also end up in a foreign prison.

The real country of customs bans has become Singapore. In addition to standard restrictions on the transport of alcohol into the country, the import of chocolate is limited - the allowed limit is not more than 50 Singapore dinars (about 35 US dollars). In addition, Singapore has truly draconian tobacco import regulations. In particular, no more than 200 cigarettes can be imported, and each cigarette should be marked "Singapore Duty-Paid Cigarettes" near the filter. Otherwise, the tourist will be fined \$ 345. Smokers should also know that each pack of cigarettes brought must be shown to the customs, and you will need to pay \$ 5 in duty for it and keep the customs receipt. In addition, the country's authorities banned the import of any tobacco and imitating products, including electronic cigarettes, as well as nicotine for local use, for example, plasters. But while customs regulations impose restrictions on tobacco products around the world, Singapore is very strict about other products. It is forbidden to import toy coins and banknotes, lighters in the form of pistols, fireworks and firecrackers, ivory objects, knives with a folding blade, including penknives, copies of copyright publications and programs on disks and cassettes. Do not favor the border and those who with themselves needed for some reason to take animals and plants listed in the Red Book and products from them. For the import of all these items you can get criminal liability, and the transportation of narcotic substances to Singapore may even result in the death penalty. But the ban on the transportation of chewing gum has become a real "calling card" of local customs. Its free sale and import was banned in 1992, after someone stuck it on the sensor panel in the subway, and there was a serious malfunction. According to another version - chewing gum was banned for environmental reasons. One way or another, if you spit out or stick the chewing gum, it will result in a fine of US \$ 700 for the offender, and its import is punishable by 1 year in prison and a fine of US \$ 5500.

Cordless Phones and Books in Chinese Tourists from all over the world travel to Java, Bali, and Sumatra, but customs problems can easily overshadow the trip. Under Indonesian law, along with drugs, pornography and explosives,

cordless phones are not allowed in the country - this requires special permission. Otherwise, the equipment may be removed. Fortunately, this restriction does not include mobile phones and smartphones, but only those phones that are usually used in homes. Indonesians have a special attitude to Chinese products - it is forbidden to import medicinal products of Chinese origin and literature in Chinese into the territory of the country.

Malaysian customs legislation also establishes a number of stringent import requirements. The import of narcotic substances is punishable by death, and when importing other goods, the case may result in a fine or a criminal term of 3 to 5 years. It is strictly forbidden to import piranhas, tortoiseshell eggs, cocoa beans, rambutans, fruits from the Philippines and Indonesia, throw knives and fabrics with the image of verses from the Koran. Feathers, pencils and other objects resembling syringes are also prohibited, and there is also a position called "Any device designed to harm Malaysia's interests." In addition, local authorities decided to support local producers by imposing duties on the import of new clothes. According to the rules, if you import more than three items of new clothes and more than one new pair of shoes, then you will need to pay a fee.

Nigeria is also famous for some absurd rules regarding imported goods. In addition to the standard prohibition, such as drugs or weapons, tourists are not supposed to import beer, champagne, mineral water, including bottles, fabrics, jewelry and precious metals, and mosquito nets were also prohibited. When these goods are imported into the country, local authorities will not only give the go-ahead, but may not let go. Illegal import of such goods is punishable by a large fine and a prison term of up to six months.

At first glance, Iran does not seem to be a country in which particularly harsh laws apply, although, like in many other Asian countries, the import of drugs is punishable by death. However, there are also national features. It is forbidden to import printed materials and video materials in which male and female photos of an erotic nature are depicted, and customs magazines can easily classify such magazines or family photos in swimsuits or where a woman is depicted without a hijab. In addition, things made in Israel, including those with a logo or images, for example, clothes, as well as any printed materials in Hebrew, were banned. Similar rules apply in several other Arab states - the UAE, Saudi Arabia, Libya and others.

An unusual ban applies in Barbados - it is strictly forbidden to import camouflage clothing into the country. Since in this country this is the prerogative of the military alone. Some prohibitions no longer apply. In recent years, the world has become increasingly open to trade and tourism, and some prohibitions are finally ending.

Before you go to another country, you need to carefully study the list of items that are prohibited to import there beforehand. It is unlikely that anyone would want to get stuck at an airport in a foreign country and pay a heavy fine. Some items should be paid special attention to - many countries prohibit their import. These include national currency, gold and jewelry, animals, plants, seeds and their fruits. In many countries it is impossible to import meat and dairy products, and almost all states that practice Islam prohibit the import of alcohol and pork products.
