- the instability of the social environment and uncontrolled migration;

- cross-border organizational crime, illegal trade in weapons and drugs;

- regional armed conflicts;

- risk of natural and man-made disasters.

There are also "positive" signs of the presence of a state border:

- complementarity of the economy of border regions;

- the possibility of using "humanitarian" resources, for example, the cultural and educational potential of a large city located near the border;

- joint use of the recreational potential of border territories (for example, the black sea coast serves as a source of joint use of recreational resources for such bordering countries as Russia, Ukraine, Georgia, Turkey, Romania, and Bulgaria);

- the need for joint measures to protect the environment, create and support existing reserves, and take measures to prevent risks of natural and man-made disasters (Russia, Kazakhstan, China, and Mongolia are interested in creating a transboundary biosphere territory (TBT) "Altai");

- creation of free economic zones;

- granting special status to areas on both sides of the border.

Conclusion. Of course, in different countries, the contact and barrier nature of borders is very different, but certainly, not one of them can be open or closed

economically [3]. Despite positive economic ties with other countries and allowing or limiting negative ones, state borders regulate the interaction of the national economy with the world. The relationship between contact and barrier state borders varies unevenly in countries with different levels of development and different degrees of involvement in the world economy.
